UNLIMITED MODELS SOUTH AFRICA (UMSSA)

RULES AND REGULATIONS

(Applicable to all Local and National Pageant Events)

1. GENERAL CONDUCT

- 1.1. All contestants must uphold the values, dignity, and good reputation of **Unlimited Models South Africa (UMSSA)**.
 - 1.2. Contestants must behave with **respect, integrity, and professionalism** toward organisers, judges, sponsors, and fellow participants.
 - 1.3. **Any form of misconduct**, including rude behaviour, defamation, bullying, discrimination, or the use of vulgar language, may result in **immediate disqualification**.
 - 1.4. Contestants and guardians may not engage in **public disputes or negative posts** on social media about the event, judges, or fellow contestants. Such behaviour constitutes a breach of contract.

2. ELIGIBILITY

- 2.1. Entry is open to **South African citizens or permanent residents** only.
 - 2.2. Contestants must compete in the **correct age group** as of the date of the Pageant.
 - 2.3. UMSSA reserves the right to request **proof of age or identity** at any stage.
 - 2.4. Contestants may not hold any other **current local or national title** that conflicts with UMSSA, unless approved in writing by the organisers.

3. ENTRY REQUIREMENTS

- 3.1. A fully completed **Entry Form**, proof of **non-refundable payment**, and **signed Terms & Conditions** must be submitted before the closing date.
 - 3.2. Incomplete entries, late submissions, or failure to comply with instructions may lead to **automatic disqualification**.
 - 3.3. Contestants must provide **accurate information**; falsification of details will result in disqualification and forfeiture of any title or award.
 - 3.4. All contestants must attend scheduled **briefings, rehearsals, and interviews** as instructed by the organisers.

4. WARDROBE AND APPEARANCE

- 4.1. Contestants must supply their own **outfits, shoes, and accessories** for each round, unless otherwise stated.
 - 4.2. Outfits must be **age-appropriate** and in good taste. Revealing or provocative attire is strictly prohibited for minors.
 - 4.3. Makeup and hair must be neat and suitable for the contestant's age group.
 - 4.4. No excessive use of fake tanning, body glitter, or makeup on children will be allowed.
 - 4.5. Contestants are responsible for their **own grooming and presentation** throughout the event.

5. REHEARSALS AND PARTICIPATION

- 5.1. Attendance at all **official rehearsals** is compulsory unless excused in writing by the organisers.
 - 5.2. Failure to attend rehearsals or briefing sessions without valid reason may result in **loss of marks or disqualification**.
 - 5.3. Contestants must arrive at the venue **punctually and fully prepared** at all scheduled times.
 - 5.4. The organisers will not be responsible for **transport, meals, accommodation, or personal costs** incurred by contestants or guardians.

6. STAGE RULES

- 6.1. Only contestants, authorised staff, and crew are allowed backstage or in dressing areas.
 - 6.2. Parents/guardians are **not permitted backstage** unless expressly authorised for minor assistance in specific categories.
 - 6.3. Contestants must follow all stage directions and respect the production team.
 - 6.4. The use of **mobile phones, cameras, or recording devices** backstage or on stage is strictly prohibited unless authorised by the organisers.

7. JUDGING AND SCORING

- 7.1. The judging panel is appointed by the organisers and consists of qualified professionals.
- 7.2. Judging will be based on categories including, but not limited to:

- Stage presence and confidence
- Personality and charm
- Grooming and presentation
- Communication and public speaking

- Overall impression and character

7.3. The judges' decisions are **final, binding, and not open to appeal or correspondence**.

7.4. UMSSA reserves the right to withhold a title if no contestant meets the minimum required standard.

8. TITLES, PRIZES AND REPRESENTATION

8.1. Winners will receive titles, sashes, and/or trophies as determined by the organisers.

8.2. Titleholders are expected to serve as **positive ambassadors** for UMSSA for the duration of their reign.

8.3. Titleholders must attend official events, photoshoots, charity appearances, and promotions when reasonably requested.

8.4. Failure to uphold ambassadorial duties may lead to **revocation of title**.

8.5. All titles remain the **intellectual property of UMSSA** and may not be used for unauthorised commercial purposes.

9. MEDIA AND PUBLICITY

9.1. UMSSA retains the **exclusive right to all photographs, video recordings, and digital content** captured during the Pageant.

9.2. Contestants grant permission for their **image, voice, and name** to be used for publicity, social media, or commercial purposes without further compensation.

9.3. Contestants may share their own photographs or posts provided such posts **promote UMSSA positively** and do not breach confidentiality or event decorum.

10. HEALTH AND SAFETY

10.1. Contestants participate **at their own risk**.

10.2. The organisers, sponsors, and affiliated entities shall not be liable for any **injury, loss, or damage** sustained during participation.

10.3. Contestants must immediately report any illness, injury, or emergency to the event coordinator.

10.4. Smoking, alcohol, or any form of substance abuse is **strictly prohibited** during the event.

11. DISQUALIFICATION

Contestants may be **disqualified** at the discretion of UMSSA for any of the following:

- Breach of these Rules or the official Terms & Conditions.
 - Dishonesty or falsification of documents.
 - Unauthorised use of the UMSSA name, logo, or branding.
 - Disruptive or disrespectful conduct by the contestant, parent, or guardian.
 - Failure to attend scheduled events, rehearsals, or appearances.

12. POPIA COMPLIANCE

12.1. All personal information is collected in accordance with the **Protection of Personal Information Act (POPIA)**.

12.2. Contestants consent to the storage and processing of their data for administrative and promotional purposes.

12.3. UMSSA undertakes to protect such data and will not disclose personal information to third parties without consent.

13. GOVERNING LAW

These Rules and Regulations are governed by the **laws of the Republic of South Africa**, and any disputes shall be resolved in the **courts of competent jurisdiction within South Africa**.

UNLIMITED MODELS SOUTH AFRICA (UMSSA) PAGEANT

TERMS AND CONDITIONS & INDEMNITY AGREEMENT

(Applicable within the Republic of South Africa)

1. ENTRY AND ELIGIBILITY

- 1.1. Participation in the **Unlimited Models South Africa (UMSSA)** pageant ("the Pageant") is open to South African citizens or permanent residents holding valid South African identification or birth certificates.
 - 1.2. Contestants must enter the appropriate **age group** as at the date of the Pageant event.
 - 1.3. Entry forms must be **completed in full** and accompanied by proof of payment of the **non-refundable entry fee**.
 - 1.4. The **organisers reserve the right** to reject any entry that is incomplete, inaccurate, or submitted after the closing date.
 - 1.5. Contestants under the age of **18 years** require the **written consent of a parent or legal guardian**.

2. CONDUCT AND REPRESENTATION

- 2.1. Contestants must conduct themselves in a **respectful and professional manner** at all times.
 - 2.2. The organisers may disqualify any contestant for **misconduct, dishonesty, or breach of these Terms and Conditions**.
 - 2.3. Winners and titleholders agree to **act as ambassadors** for UMSSA and must uphold the good name and reputation of the Pageant.
 - 2.4. Contestants may not represent or promote competing pageants **during the reign period** unless prior written consent is obtained from UMSSA.

3. FEES AND REFUNDS

- 3.1. The entry fee is **non-refundable** under any circumstances, including withdrawal, disqualification, or cancellation due to factors beyond the organiser's control.
 - 3.2. All payments must be made into the designated **UMSSA bank account** or via the approved online link.
 - 3.3. Proof of payment must accompany the entry form.

4. EVENT ARRANGEMENTS

4.1. Dates, venues, and formats are subject to change at the discretion of the organisers.

4.2. The organisers shall not be liable for **travel, accommodation, or personal expenses** incurred by contestants.

4.3. UMSSA reserves the right to **amend, postpone, or cancel** the Pageant due to unforeseen circumstances such as weather, venue unavailability, or government restrictions.

5. JUDGING AND RESULTS

5.1. The decision of the judges is **final and binding**. No correspondence, appeal, or discussion shall be entered into.

5.2. Judging criteria shall include, but not be limited to, **poise, confidence, appearance, personality, and overall presentation**.

5.3. Titles and awards are conferred at the sole discretion of UMSSA and **remain the intellectual property of the organisers**.

6. USE OF IMAGES AND MEDIA RIGHTS

6.1. By entering, contestants (and guardians where applicable) grant UMSSA **full and unrestricted rights** to use their name, image, photographs, videos, and likeness for publicity, advertising, broadcast, and online promotion without further consent or remuneration.

6.2. All photographs, recordings, and materials produced during the Pageant remain the **property of UMSSA**.

7. INDEMNITY AND WAIVER OF LIABILITY

7.1. Participation in the Pageant is **entirely at the contestant's own risk**.

7.2. UMSSA, its organisers, sponsors, judges, affiliates, and staff shall **not be liable for any injury, loss, damage, illness, or death** sustained by any contestant, parent, or guardian, whether arising from negligence or otherwise, before, during, or after the event.

7.3. Contestants and guardians hereby **indemnify and hold harmless** UMSSA and its representatives from all claims, demands, actions, or damages arising from participation in the Pageant.

7.4. Contestants agree to **comply with all venue, safety, and health regulations** during the Pageant.

8. PERSONAL INFORMATION AND COMPLIANCE WITH POPIA

- 8.1. UMSSA shall process all personal information provided by contestants in accordance with the **Protection of Personal Information Act, 4 of 2013 (POPIA)**.
- 8.2. Information will be used solely for the purposes of administration, marketing, and event communication related to the Pageant.
- 8.3. Contestants may request access to, correction, or deletion of their personal data in accordance with POPIA.

9. GOVERNING LAW AND JURISDICTION

- 9.1. These Terms and Conditions shall be governed by and construed in accordance with the **laws of the Republic of South Africa**.
- 9.2. Any dispute arising shall be subject to the **exclusive jurisdiction of the courts of South Africa**.
- 9.3. The organisers' **interpretation of these Terms and Conditions is final**.
